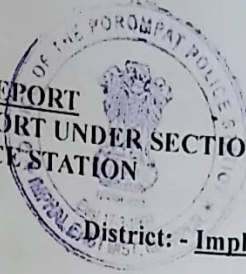

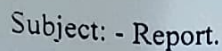

I have the honour to report that today i.e., 28/08/2023 at about 10.30 am received a reliable information about the presence of some active cadres of RPF/PLA, an outlawed banned organization with a view to commit prejudicial activities like extortion of money, threat to Govt. employees and businessmen etc. in and around Mahabali crossing area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW and myself under the supervision of M. Amit Singh, MPS, ASP(Ops.) IW rushed to the said area after giving prior information to OSCAR 50 Imphal East control room and conducted search operation at Mahabali crossing near the car wash. During that one person was standing near the car wash in a very suspicious manner. Due to his suspicious manner he was detained for spot verification. On spot body search, one Samsung Galaxy J5 Prime mobile handset model no. SM-G570F along with 2 (two) SIM cards i.e. (i) 1(one) JIO SIM card bearing number 89918650400009958820 (Ph. No. 7005587077 as disclosed by him) and (ii) one Airtel SIM card bearing number 8991160990017753356U (Ph. No. 8798372806 as disclosed by him) and one wallet brown in colour containing 1 (one) Aadhaar card and a sum of Rs. 2,160/- (Rupees two thousand one hundred sixty only) were found from his possession.

On spot verification, he identified himself as Moirangthem Oken @ Suraj @ Rubi @ Somorjit (53 yrs) S/o. M. Ibomcha Singh of Khurai Kongpal Laishram Leikai. On preliminary questioning, he disclosed that he is an active cadre of RPF/PLA organization and joined the said organization in the year 1992 through one Suresh Baiya of RPF/PLA organization. He got 45 days basic military training at Bangladesh and allotted army number 443 of 9<sup>th</sup> batch of RPF/PLA organization. Presently he is holding the rank of Lance Corporal of RPF/PLA organization and presently working under the command of s/s Major Robertson from Khurai Puthiba and Mr. Khelemba @ Hemba (Finance section) presently staying at Myanmar of RPF/PLA organization. He further stated that under the instruction of his commander he extorted huge amount of money from various private establishment i.e., wine shops, fish centre, grocery shops in and around Imphal West and East area. And extorted money had been handed over to his commander Mr. Khelemba @ Hemba through one unknown person sent by him for their party fund. He further disclosed that he frequently contact his commander through mobile phone (8794013857). Hence, he was arrested at the spot at 11.30 am and recovered the above mentioned articles are seized at 11.40 am by observing necessary formalities.

Hence, the arrested person along with seize articles are handed over to you for taking further necessary legal action against him.
