With reference to the subject cited above, I would like to inform you that there has been a colossally frightening breach of looting of my possessions (properties)from my rental house and massive burning down all the houses including my rental house of all Meitei community by an ethnic group of Kuki including armed militants. My rental house is situated at Meitei Leikai, Ward no. 6 in Moreh and the owner of my rental house is Khwairakpam Memcha Devi, w/o (Late), Kh. Basanta Singh.

The unfortunate incident occurred at evening around 6 AM on 4th May, 2023. In the shocking and frightening breach, the burglars had looted all my possessions of worth approximately Rs. 9,10,800.00 (Nine lakhs ten thousand eight hundred only). A list of properties which I possess and have been looted from my rental house is attached.

I, the complainer, have been posted as an Assistant Professor in Moreh College, Moreh for the last 20 years. My Employee Identification Number (EIN) is 110893 under Department of University and Higher Education, Government of Manipur.

Therefore, I would like to kindly request your good self to register this complaint as an F.I.R. I shall be thankful for your kind cooperation in this matter.
