Sir,

I have the honour to state that, on 04-05-2023 at around 3:10 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 400-500 persons carrying deadly weapons, forcefully entered our locality, New Checkon, near Baby Seikam English High School, Imphal East Dist. Manipur, about 44 km South from Saikul-PS and carried out anti social element. In the incident the violent mob completely destroyed my four wheeler vehicle (Maruti Ertiga Smart Hybrid Top model bearing regd. No. MN01 AG 4114 ) worth about Rs.11 lakhs, which was parked outside my house.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
