I have the honour to state that, on 04-05-2023 at around 3:10 pm some unknown miscreants auspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Suspections, Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 400-500 persons carrying deadly weapons, forcefully entered our locality, New Checkon, near Baby Seikam English High School, Imphal East Dist. Manipur, about 44 km South from Saikul-PS and carried out anti social element. In the incident the violent mob completely destroyed my four wheeler vehicle (Maruti Ertiga Smart Hybrid Top model bearing regd. No. MN01 AG 4114) worth about Rs.11 lakhs, which was parked outside my house.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action

against the culprits according to law.
