Sir,

I am to state that, on 4th May 2023 at about 1: 00 pm, our locality Checkon Nongpok Ingkhol near KBC Centre Church, New Lambulane was under mob attacked by hundreds of miscreants belonging to the Meitei community with criminal intention to cause damage of property and life.

As a result, many houses and properties including Church worth crores were destroyed, looted and burnt. Among which my rent house (two rooms in first floor) owned by Mrs Lamkhohoi Lupheng which was located adjacent to KBC Centre Church was also destroyed by the mob and all my properties were looted and left-overs were vandalized.

Lists of properties looted and destroyed are given below:

1. Furniture includes Wooden Kingsize bed-01, Wooden almirah-2, Steel Amirah-1, Sofa sets along with cushion, Bed box, Dining Table with chairs, Dressing Table
2. Electronic items includes Automatic Washing machine (Whirlpool brand), one Refrigerator (Samsung brand), One television (Samsung brand), One Asus Laptop 13th gen. model, cooler, heater, oven.
3. ornaments worth-2 lakhs
4. Clothing & dresses for 4 members
5. 3-cylinder gases and stoves
7. Livestock (poultry) worth 4 lacs
8. Cash- 1.5 lacs
9. Miscellaneous

The approximate total loss of properties would be Rs 15 lakhs

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
