I have the honour to report that on the 7<sup>th</sup> May 2023 at around 5:00 P.M.  
some unknow miscreants suspected to be a volunteer of Arambai Tenggol,

K.prem meitei at Mandap Leirak, New Checkon Room no. 11 Imphal East and

Clothings, Electronic device (Laptop, Mobile phone, Printer etc.) and One two
