With due respect I would like to state that my house located at Chassad Avenue , Near Brighter Academy, PS-Porompat, Imphal was under attack by some unknown miscreants suspected to be Meitei Youth in between 23/7/2023 to 31/7/2023 looted properties and Vandalised the house.

Total Property loss is estimated at Rs. 50,44,300/- (Fifty lakhs forty four thousand and three hundred) only.

The approximate value of Pucca building is Rs. 9, 70,00,000/-(Nine crore seventy lakhs) only.
