Sir,

I have the honour to state that, On 07-05-2023 at around 9:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 800-900 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at Newlambulance, Imphal East about 42 km South from Saikul-PS. and they vandalised my house and looted all the moveable and valuable properties and burnt down all the remaining into ashes leaving us homeless. The list of properties destroyed or loss are mentioned in the Annexure (enclosed). The Approximate value of Damaged or loss properties is calculated at about Rs 5,45,500/-(Five lakhs forty five thousand and five hundred) only.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
