Subject: Report on Vandalism, Looting and Burning of Property.

Sir,

With due respect I, Thangkhola Haokip age about 33 years H/O Lhingjaneng Haokip a resident of Haokip Veng, Palace Compound Imphal P.O. Imphal P.S. Porompat, District Imphal East Presently staying at T.Vankotnom, Tuibuong Block, Churachandpur would like to report that, I am staying in a rented house at the mention address at the onslaught of ethnic clash between The Meitei and Kuki Zo Community in Manipur that on the 4th May 2023 at around 11:00 AM a group of Meitei numbering to around 500 to 1000 came and attacked Kuki-Zo Community in the vicinity of Haokip Veng.

That, this miscreant mob started to vandalize and rob our property who eventually burnt those remaining property estimated to be at a worth of Rs.20,00,000/- (Rupees Twenty Lakhs only) of property was burnt down in this Arson which cause lots of mental pain and material loss to me. Include of furniture, electronic and household goods.

It, may also be mention that my car I-10 Hyundai Activa 5G- Scooty MN-01D 8376 and 4(four) san of Gold ornament were also burnt in this criminal activity.

And that, I along with my family made a narrow escape from these criminal activities after fleeing towards 1st MR and eventually made to Churachandpur under tight security escort. And I am making this report at the earliest possible time after frequent shifting of places.

I therefore, request your kind office to lodge my report so that the perpetrator of this crime may be booked under the provision of Law for the end of Justice.
