- That, 1 am a Scheduled Tribe belonging to Any Kuki Tribe which is a recognized Scheduled Tribe under the Constitution of India.
- That, the above mentioned school is a Govt. Aided School, originally designated for Loutei Kuki Village, P.O. & P.S. Litan, District- Kamjong, Manipur. But, due to the unfortunate destruction of the Village School by fire in the year, 1993, the said aided School was temporarily continued at New Lambulane, Imphal via Govt. of Manipur Order No. 2/1/97-SE(S)/ Temp: dated Imphal, the 18th June, 1997.
- 3. That, due to the on-going ethnic violence in the State of Manipur that has started on the 3rd of May, 2023, we had left New Lambulane for our safety on the 9th of May, 2023. And, recently we have come to know that our said school was looted and vandalized by Meitei miscreants thereby causing loss of the following School properties:
