Dear Sir,

With reference to the above cited subject, I, the undersigned, Head Master of Loutei Kuki Aided L.P. School, have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to Any Kuki Tribe which is a recognized Scheduled Tribe under the Constitution of India.
2. That, the above mentioned school is a Govt. Aided School, originally designated for Loutei Kuki Village, P.O. & P.S. Litan, District- Kamjong, Manipur. But, due to the unfortunate destruction of the Village School by fire in the year, 1993, the said aided School was temporarily continued at New Lambulane, Imphal via Govt. of Manipur Order No. 2/1/97-SE(S)/ Temp: dated Imphal, the 18th June, 1997.
3. That, due to the on-going ethnic violence in the State of Manipur that has started on the 3rd of May, 2023, we had left New Lambulane for our safety on the 9th of May, 2023. And, recently we have come to know that our said school was looted and vandalized by Meitei miscreants thereby causing loss of the following School properties:

1.	School Building	Rs. 12,00,000.00
2.	Furniture and Teaching aid items	Rs. 3,00,000.00
3.	School Kitchen and potteries/ plates	Rs. 5,00,000.00
4.	Misc.	Rs. 5,00,000.00
Total		Rs. 25,00,000.00



4. That, the total loss caused by the above mentioned criminal activities may be estimated to be approximately Rs. 25,00,000/- (Rupees Twenty Five Lakhs) only.
5. That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
