Subject : Report.

Sir,

I have the honour to state that, with the outbreak of communal conflict in Manipur since May 3<sup>rd</sup> 2023 there have been serious concerned about threat to life in Imphal valley as a result of which me and my family are compelled to flee to a nearby safe location. So I alongwith my family left our rented house leaving all our belonging, household properties and good and fled to Mantripukhri Assam Rifle camp in order to save ourselves. With the help of Central Security force we have been evacuated to Kangpokpi District and as of now we temporarily stayed at C. Aisan relief camp, under Kangpokpi District, Manipur.

Further, It is learnt that, On 15/05/2023 some unknown miscreants suspected to be belonging to Meitei community have vandalised our rented house at New Lambulane, Imphal East Dist. Manipur about 42 Km south from Saikul -PS and looted all the valuable and moveable household properties. The list of properties destroyed or loss are mention in the annexure (**Enclosed**). The Approximate value of the lost properties is calculated at 16,82,000/- (Sixteen lakhs eighty two thousand).

Due to lack of legal knowledge I could not report the incident timely to the concerned authority.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
