My rented house including house hold items amounting to Rs 1980000- (Nineteen Lakh eighty thousand) approximately which is located at Moreh Turelwangma Leikai ward no.7 was also burnt in this incident.

Therefore you are requested to take up necessary legal action against the accused culprit according to law of land as early as possible.
