



I, the undersigned have the honour to state that subsequent torched of Meetei houses by armed kuki militants and unidentified group belonging to kuki community at Moreh from 3<sup>rd</sup> May 2023, they arsoned many houses of Meitei community recently on 26<sup>th</sup> July 2023 at 11:30 am again. My House including Household items amounting to Rs,87,00,000/- ( eighty seven lakhs) approximately which is located at Moreh Khunou Leikai ward no.9 was also burnt in this incident.

Therefore you are requested to take up necessary legal action against the accused culprit according to law of land as early as possible .
