

**Sub: Report of damaged and left properties.**

Sir,

I hereby write this letter to draw your attention that on the 4<sup>th</sup> May 2023, Mr. Limlensei Hangshing Aged about 34 year S/o (L) Paogoumang Hangshing and Mrs. Hekim Hangshing, was attacked by a group of Meitei/Meitei goons at my residential home, owned and registered in my name Limlensei Hangshing Patta No. 855, covered by C.S. Dig No. 5479/5553 an area of 0.43 acre of 26 (A).

The criminals broke the gate destroyed so, we have to leave our house. The residential building comprising of the following:-

1. Furniture set worth	Rx. 6 Lakh
2. Electronics Gadgets worth	Rx. 2 Lakh
3. Essential Commodities worth	Rx. 5 Lakh
4. Jewellery and ornaments worth	Rx. 2 Lakh
5. Dresses and Books worth	Rx. 80 Thousand
6. Building	Rx. 72 Lakh

The total loss is estimated to be a region amounting Rs. 87 Lakh 80 thousand only. Fortunately, all family members managed to escape from the incidents.
