

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to kuki community with deadly weapons and sophisticated arms including kuki Militant Group(s) stormed to all Meitei inhabited areas of Moreh town on 26/07/2023 at 04.30 pm. The said unidentified groups vandalized my house located at Prem Nagar Loubuk Leikai Ward No. 5 and looted all valuable items. In the unfortunate incident, I have lost a total amount about Rs. 30,00,000/- (Rupees Thirty Lakhs) approximately. That, the incident was begin from 03/05/2023. So, I and my all family members are taking shelter at relief camp situated at Kongpal Kongkham Leikai, (Khurai - 3) Imphal East District, Manipur. That, the incident was happen while I and my family were staying at the said relief camp.

It is therefore requested to kindly take necessary legal actions against the accused persons and the persons involving in the said inhuman acts and heinous crime according to law.
