

I the undersigned have the honour to state that on 22nd July 2023 at 2:00pm, some unknown angry mob holding deadly weapons numbering about 1000 suspected to be meitei community entered our rented house (owner L Kimboi Haokip w/o Seikholen Haokip) at Chassad Avenue, Haosa Veng, Opt: ICI Church, Brighter Academy Road, New Checkon, PS: Porompat, Imphal-East, Manipur-795001, and started damaged properties and burning houses.

The following documents including properties were damaged and burned during the incident:-
