Subject: Report for registration an FIR for serious criminal acts and for transferring it to Moreh Police Station under whose jurisdiction the incident occurred.

Sir,

My son Raynav Trehan (minor) owns a small piece of land at Moreh Tali galli under Patta No. 3181 under Dag No.3050 on which I had constructed a small two storey pucca building. On the night on 28th Aug²³ there was vandalism of the properties by kukis and on the morning of 29th Aug²³ all the properties inside the house belong to me were looted and reportedly carried away in a truck. The information of the incident was received very recently since there is no responsible person to communicate with me.

The detail of the properties looted along with the approximate value is attached for kind reference and the total value comes to about Rs. 5,67,000/-.

In the above circumstances, it is humbly requested that necessary FIR may be registered and the same transferred to Moreh PS as it is not physically possible to go to Moreh to lodge the FIR. So that investigation may be conducted at the earliest to book the culprits under the laws of the land for looting, intimidation and vandalism using deadly weapons and bring them to justice.

I, undersigned on behalf of my son will be grateful if necessary action is taken up from your end without delay.
