Subject - Report on crimes of **vandalism, looting, arson-attack, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Valphel Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Sanathoi Devi @ Julia (Contact No.-8119080045) located at Room no-2, 2nd Floor, Julia Apartment, Soibam Leikai, New Checkon, P.O. & P.S.- Porompat, District- Imphal East on the *4th of May, 2023* at around *10.00 AM*, it has come to our knowledge that our deserted house was attacked, destroyed and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambui Tengol, Meetei Leepun and other local Meeitei/Meiteis in and around the are on the *5th of May, 2023* at around *4:30 PM*, along with 2(Two) Vehicles, which was torched at the above-mentioned location, namely;

a) *Maruti Suzuki, Swift-2015 model (used vehicle), regn. no- MN01A 7829, Silver in colour, registered under the name of my brother @ 'Thanglian Baite', which is estimated to be worth Rs.4,00,000/- (Rupees Four Lakhs) Only.*

b) *Yamaha Fascino 2018 model, regn. no- MN06 SB 4166, Blue in colour, registered under the name of my wife @ 'Nemneilam Baite', which is estimated to be worth Rs.1,02,000/- (Rupees One Lakh Two Thousand) Only.*

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's along with the 2(two) mentioned vehicles, the total worth is about Rs. 35,00,000/- (**Rupees Thirty-Five Lakhs**) only.

That, it may be reported here that the miscreants were shouting slogans like, "KANGLEIPAK YAIPIHARE", "KUKI HATLO", "HAO HATLO"; etc. while they were carrying out their criminal activities.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places and filing a FIR Application was not possible at that time as I was mostly at the remote areas. And now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
