

Sir,

I have the honour to state that, on 4-05-2023 at around 02:15 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol, World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) and women folks, numbering about 1000 persons carrying deadly weapons and Arms deliberately attacked the residence of Kuki community in Imphal, in which my rented house located at Checkon, Hapta Golapati, Imphal East, about 45 km South from Saikul Police Station, was totally vandalised and damaged. All my valuable and moveable house hold properties were also looted in the incident. Fearing lost of life, I left my rented house and fled to nearby safe location at 1st MR Imphal. Later on Evacuated to Kangpokpi District by Central Security Force.

The list of properties destroyed or loss are mentioned in the **Annexure(enclosed)**. The Approximate value of lost properties is calculated at about Rs. 1,82,000/- (One lakh eighty two thousand).

Due to lack of legal knowledge I could not report in time.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
