

Sir,

With due respect, I would like to request your kind authority for taking necessary action regarding the above mentioned subject.

That, I had rented a house owned by one Gurumayum Joychandra Singh at Palace Compound, near Bheigo Saw-Mill, Andro Parking, Imphal East, Manipur. However, due to the prevailing communal violence that broke out from 03-05-2023, I had abandoned my rented house on the 4th May, 2023.

That, during the first week of August, 2023, I came to learn from my neighbours that my rented house was attacked, broke opened and all my properties (mentioned below) were stolen away by unknown miscreants during the last week of May, 2023. All my household properties which were stolen away by the unknown miscreants were worth Rs. ~~15~~⁸ Lakhs (approx.).

It is, therefore, requested to kindly take up necessary legal action against the unknown miscreants and help recover my stolen properties.

Cause of delay in reporting on time is due to my displacement.


