

Subject: Report on looting of household properties.

Sir,

I am being informed that my rented house located at New Lambulane, River Bank Side, near Nongpok Thong, Imphal East, have been ransacked by some unknown persons and looted my household properties worth Rs. 18,82,000 (Rupees Eighteen Eighty Two Thousand).

A neighbour informed me of the looting of my household belongings on 13th September, 2023.

In this connection, I am providing below a list of my household properties taken away by the looters for your kind reference:

1. Electronic home appliances - Samsung TV (55 inch) with Sound System, Samsung Refrigerator (253 ltr), Inverter with two tubular batteries (large), Samsung Washing Machine (8 kg), Phillips Oven (48 ltr), Air Fryer (5 ltr), Bosch Vacuum Cleaner, Bosch Car Pressure Sprayer and others worth Rs. 4,50,000 (Rupees Four Lakhs) in total.
2. Two sets of desktop computers along with tables and chairs, and one A3 printer & two laser printers worth Rs. 3,50,00 (Rupees Three Lakhs Fifty Thousand) in total.
3. Six steel closets along with clothes worth Rs. 3,00,000 (Rupees Three Lakhs).
4. Four Beds along with orthopaedic mattresses and blankets stored in two large trunk boxes (3x4 ft each) worth Rs. 3,00,000 (Rupees Three Lakhs Fifty Thousand) in total.
5. Kitchen utensils including Usha Gas Burner/Stove (hardened glass) and five LPG cylinders worth Rs. 1,50,000 (Rupees One Lakh Fifty Thousand) in total.
6. Sofa set along with cushions worth Rs 1,20,000 (Rupees One Lakh Twenty Thousand) in total.
7. Footwears worth Rs 1,00,000 (Rupees One Lakh) in total.
8. Properties stored in the warehouse worth Rs. 90,000 (Rupees Ninety Thousand) in total.
9. Plastic water tank/storages (One 2000 ltr & three 1000 ltr tanks) worth Rs. 22,000 (Rupees Twenty Two Thousand) in total.

If I may add, me and my family members were among the displaced persons evacuated from the 1st MR camp (Imphal West) to Churachandpur district on 9th May, 2023.

I, therefore, request that an FIR against the looters of my household belongings be registered under relevant section of the Indian Penal Code.
