

Sir,

With reference to the above cited subject, I have the honor to report to you as below:

1. That, I Thanglenlal Haokip age 41 S/o(L) Jangmang Haokip belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. By which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act 1989. Whereby, I had stayed at Rent at New Lambulane 1st street P.S Porompat, District Imphal East,

2. That on, 6 May 2023 2pm huge contingent of Armed Radical Meitei/Meiteis, Arambal Tenggol and Meitei Leepun attack my rented House, Coaching centre and Girls Hostel, and in the process burnt/looted/vandalized my house and properties.

3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.67 Lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to killed us. Henceforth, we are taking refuge at ADC Complex Tuibong, Churachandpur.

I, Therefore, request you to register FIR and bring justice.
