2. That on, 6 May 2023 2pm huge contingent of Armed Radical Meitei/Meiteis, Arambal Tenggol and Meltei Leepun attack my rented House, Coaching centre and Girls Hostel, and in the process burnt/looted/vandalized my house and properties.

3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.67 Lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to killed us. Henceforth, we are taking refuge at ADC Complex Tuibong, Churachandpur.

I,Therefore, request you to register FIR and bring justice.
