By virtue of which I am entitled for protection under the SC/ST (Prevention of Atrocities) Act,1989. Whereby, I had stayed as rented at New Lambuland 1sr Street, P.O & P.S Porampat,Imphal East District.
- 2. That, on 4 may 2023 at 11pm, a huge contingent of armed radical Meitei/Meitei Mobs, Arambai Tengol and Meitei Leepun along with State Force like Manipur Police Commando and Indian Reserve Battalion(IRB) attack our Village, and in the process looted/vandalized/burnt our Rented house and properties
- 3. That, the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.29 lakhs 60 thouand only.
- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at New Zou veng, Churachandpur District.
- I, therefore, request you to register on FIR/ZERO FIR and bring justice
