Dear Sir,

I, V.Thangzasiem aged about 71 years s/o (L) V. Khamlian, a resident of Bungmual Lamlian Veng, Ward No. 4, P.O & P.S. Churachandpur, Manipur is the owner of the semi-pucca house at residential Plot Patta no. 961 of Dag. No. 4437 in Maring Lane, Western New Checkon Road, P.O. Imphal & P.S. Porompat, Imphal East, would like to inform you that, on the 5th day of August 2023 at around 6:00 pm, some miscreants believe to be valley based militants stormed into New Checkon Road, Maring Lane localities attacking those houses and property belonging to the Kuki-Zo ethnic tribes by looting, vandalize and setting fire on it, burning down all our house and property including my semi-pucca House at Residential Plot Patta no. 961 of Dag. No. 4437 in Maring Lane, Western New Checkon Road.

That, in this wanton act my house as mentioned above was completely burnt down which may amount to INR 40,00,000/- (Rupees Forty Lakhs only) and a household property belonging to that of my tenant Mr. Hauminlun Neihsial estimated to be a value of INR 8,10,000/- (Rupees Eight Lakhs Ten Thousand only) as enclosed.

I am, Therefore, would like to request you to kindly take necessary action at the earliest for the end of justice as following :
