Churachandpur, Manipur is the owner of the semi-pucca house at residential Plot Patta no. 961 of Dag. No. 4437 in Maring Lane, Western New Checkon Road, P.O. Imphal & P.S. Porompat, Imphal East, would like to inform you that, on the 5th day of August 2023 at around 6:00 pm, some miscreants believe to be valley based militants stormed into New Checkon Road, Maring Lane localities attacking those houses and property belonging to the Kuki-Zo ethnic tribes by looting, vandalize and setting fire on it, burning down all our house and property including my semi-pucca House at Residential Plot Patta no. 961 of Dag. No. 4437 in Maring Lane, Western New Checkon Road.
