- 2. That, on 3rd May 2023, at 6:30pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our Rent, and in the process burn/looted/vandalized our house and properties.
- 3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.3 lakhs 80 thousands only.
- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to killed us. Henceforth,we are taking refuge at Hq Belam Veng,Churachandpur
- I, Therefore, request you to register FIR and bring justice.
