With reference to the above cited subject, I have the honor to report to you as below:

1. That, I Kimkhophal Gangte **age 62 D/o Kalkhogin Gangte** belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India. By which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act 1989. Whereby, I had stayed at **Rent** at New Checkon, **P.S , Porompat , District Imphal East.**
 2. That, on **3rd May 2023**, at 6:30pm huge contingent of Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun attack our **Rent**, and in the process burn/looted/vandalized our house and properties.
 3. That, the above said Criminals with their inhuman activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be **Rs.3 lakhs 80 thousands only.**
 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at **Hq Belam Veng, Churachandpur**
- I, Therefore, request you to register FIR and bring justice.
