- That, I, S. Thangpu Vaiphei age about 49 years h/o Kholneo Vaiphei belonging to the Vaiphei Tribe/Community, a Schedule Tribe recognized under the constitution of India. By virtue of which I am entitled for protection under the SC/ST (Prevention of Atrocities)Act, 1989, and that I along with my family stayed in a District, Manipur.
- 12. That, on the 4th of May 2023 at 10:00 am, due to the ethnic violence in the state, me and my family have to run for our lives leaving behind our rented house along with all our belongings and in the process some unknown miscreants have looted our rented house including all our belongings which is located in the above mentioned address.
- 13. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 5, 25,000 (five lakhs twenty five thousands) only.
- 14. Fortunately, I managed to escape from the violence, and now currently taking refuge at Youth Hostel, Hiangtam Lamka Relief Camp.
- 15. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned relief Centre. And thus I am filing this report lately today.

In the given circumstances, I humbly pray you to kindly register an FIR, and investigate it into the matter for punishing the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always thankful to you and obliged
