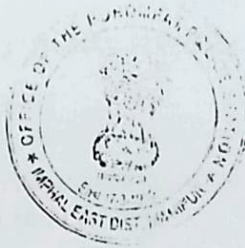

It is, therefore, requested to kindly take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime according to law
