Today, i.e., 01.11.2023 at about 5:30 p.m., it is learnt that at about 5 pm on the same day, a large number of Arambai Tenggol, led by one Korou Nganba Khuman armed with sophisticated weapons, sticks and other deadly weapons, wearing camouflaged dress, Manipur Police uniform and black colour shirt coming in many light vehicles gathered at Palace Compound, Imphal East after a call was given in Facebook page by their leader Korou Nganba Khuman as "Echil enao Athouba sing lakpiro ngasidi tang taba ama khanghalasi" translated literally as "Please come all brave brothers, let us teach them a final lesson today". On received of the information, police team of Imphal East police responded and the armed Arambai Tenggol members were stopped at near Palace gate, but the large number of Arambai Tenggol fired at the police team. In that Imphal East District Police including CDO-IE have fired some rounds of tears gas shells and live rounds in order to stopped thier despicable action/movement but they overpowered and proceeded towards Imphal West side in many light vehicles through Sanjenthong bridge towards Imphal West side to commit prejudicial activities like to attack security personnel and looting of arms and ammunicions from Manipur Police armed battalions.

Hence, a suo-motto case under FIR No. 1345(11)2023 Porompat PS u/s 147/148/149/186/188/307/379A/395/504/505/506/34 IPC, 18 UA (P) Act, 6(1)(a) Official Secrets Act & u/s 25 (1-B) Arms Act has been registered against the accused and others for investigation.
