Sir,

I have the honour to report that since 1 (one) month some unknown person is continuously stealing various item viz. gas cylinder, electrical wire, bulb, iron door etc., from my Farm House namely "Tips Top piggery farms" located at Kshetri Bengoon Chingya, Imphal East, Manipur. However, today i.e. 01/11/2023 at about 4:00 pm, 2 (two) unknown person was caught red handed while stealing Iron door from the said farm house. On interrogation upon the two unknown persons both were established their name as Ibungo 21 years and Zahid 18 years S/o Ibocha & Nazima of Kshetri Bengoon Chingya, however they were escaped/run away while interrogation with them from the open farm house. The value of stolen items from the farm house is probably Rs. 3,00,000/- (three lakhs)

It is, therefore, requested to kindly take up necessary legal action against Ibungo and Zahid according to law.
