

Subject: - Report

Sir,

I have the honour to report that on 01/11/2023 at about 6:00 pm to 6:30 pm, a large number of suspected to be Arambai Tenggol wearing camouflaged and black color shirt armed with sophisticated weapons, sticks and other deadly weapons were coming in many light vehicles from Palace Compound side toward Sanjenthong, Imphal East. On reaching Sanjenthong they attacked the Police on duty at Sanjenthong and forcibly snatched (1) 4 nos of AK rifle magazine with 120 live rounds (2) 7 nos of BP Jackets (3) 4 nos of Patka helmet (4) some uniform issued to MR/IRB personnel detained for duty at DGP Crossing kept at Sanjenthong Police Packet while most of our personnel were on duty at DG crossing for maintaining law and order duty in view of the prevailing law and order situation in the state of Manipur.

It is, therefore, requested to kindly take up necessary legal action against against the accused and others for investigation.
