The said two persons claimed to be members of the proscribed KCP and made a monetary demand of some amount and after telephonic talk it is learnt that the said two persons were sent by one Rahul Yadav who is presently residing at Kohima, Nagaland.

(The said two persons approaching my shop have been captured on my CCTV camera and softcopy of the same is enclosed for your kind perusal and reference).

In the facts and circumstances stated herein above, I am therefore submitting the present application for taking up appropriate action according to law and to provide security in and around the area of my shop site (if possible) and to book the said persons according to the law of the land.
