

Sir,

I have the honour to report that I along with my son had left from my rented house located at Soibam Leikai opposite Meri Leirak for Madhya Pradesh to my daughter's quarter since 30th May 2023. On 12/11/2023 afternoon, when I along with my son came back my home, the door of the said rented house was found unlocked after breaking the lock and the following items were stolen away by some unknown persons. It is suspected to be stolen away while we were at Madhya Pradesh for the last few days back. The stolen items are as 30 (thirty) sans of gold ornaments, one Gas cylinder and some cloths altogether value about Rs. 6,60000/- (six lakh and sixty thousand).
