Subject: FIR on my looted properties from my resident at DDK Staff Quarter
No. C/17, Porompat, Imphal East, Manipur on the 16th Oct. 2023.

Sir,

With due respect, I Tongzalam Simte (age 57 years) S/o T.Tongkhohal of T.Mimjang Thingkangphai, Churachandpur District, Manipur, would like to lodge an FIR regarding looting of my Household items and properties kept in DDK Staff Quarter No. C/17, Porompat, Imphal East on the 16th October, 2023 at around 8.00 am. That Sir, due to the communal conflict between Meitei & Kuki-Zo community erupted suddenly in Imphal valley on 3rd May, 2023, my family along with several families of Kuki-Zo community were transported to a safer place - IGAR, Mantripukhri, Imphal by Indian Army on the 7th May, 2023 leaving behind all our household items and properties in our Quarter by locking with a key and the same keys were handed over to our Office Staff Quarter Care-taker Shri R.K. Amarjeet Singh, PEX, under the instruction of the Head of Office to safeguard and protect our belongings from unwarranted activities till normalcy restores in the state.

Hence, no unwarranted activities were arisen and our belongings were safe and untouched till 15th Oct., 2023. Unfortunately, on 16th October, 2023 at around 8.00 AM, I have come to learnt from a reliable source that my Quarter No. C/17 was opened and allowed outside miscreants to loot all my belongings and properties and emptied my Quarter. This proved that this malicious act of looting is the handiwork of Shri R.K. Amarjeet Singh, PEX (Quarter In-charge).
