



I have the honour to report that from the 3rd May 2023, the Valley Meitei Radicals in Imphal Manipur attacked the Tribal and we were compelled to flee from our house in order to save our lives leaving behind all our properties and belonging in the house. It is learned that our house and belongings were being ransacked and looted.
