Subject:- Request to take action against Pranabananda Das S/O Late Himangshu Das of Sunanda Enclave Harimandir Gali, Club Road, Silchar Opposite to Petrol Pump (Near Government Girl's H.S. School), P.O.-Silchar & P.S.-Silchar, District-Cachar, Assam-788001 for committing cognizable offences punishable under Section 153A, 200, 295, 298, 505, 499, 120B, 34 IPC etc.

Sir,

1, the undersigned beg to state the following few lines for your kind consideration and necessary action:

OFFICE

- 1. That, I am a social worker and actively involved in bringing peace and harmony in violent ridden State of Manipur, I came to know on 22rd November, 2023that the accused has written a controversial Book namely "Manipur Files" which has been published by White Falcon Publisher having its office situated at Chandigarh. On bare reading of the said Book, the said Book "Manipur Files" written by the present accused are false, fabricated, sponsored and accordingly, the present accused has committed the offences under Section 153A, 200, 295, 298, 505, 499, 120B, 34 IPC etc.
- 2. That, it has been found the following false and fabricated story written by the accused:

Chapter 1 (Page 4 last para to page 5)

"However, this infamous Manipur Police Service (MPS) officer Ibomocha Singh remains on duty. He is clearly accused of being the one who handed over Tonsing to the rioters that day. Furthermore, he is accused of passing over thousands of sophisticated firearms from the Manipur police to protesters. This is mentioned in the Central Intelligence Agency's report. Still no action has been initiated against this controversial cop."

Chapter 2 (Page 7 last para)

Now coming back to this mayhem, Arambai Tengal and Meitei Lipun, two extremist organisations are fighting in support of the Meitei community, majority population of the state, in this ongoing conflict. By this point in time, the Meites were fully aware that they would lose control over the state if the Kukis continued to control Kangpokopi district. The area is geo-politically extremely significant as NH 2 goes through Kangpokopi. It is pertinent to mention that this NH is the main supply chain for the state and Kukis inhibiting the area was a major disadvantage for the Meites.

Chapter 2 (Page 9 1st para)

The dateline is June 12, 2023. Ten days have passed since Amit Shah, the union Home Minister, visited riot struck Manipur. On that fateful morning, villagers noticed considerable movement of police on the route leading up to Khamenlok hill. Initially, people speculated that the police may be conducting normal patrols nearby. However, the word got to the Kuki volunteers in Khamenlok in no time. They could surmise that a significant threat might be approaching them. Therefore, an urgent message was quickly in circulation, and preparations for the evacuation of the Kuki women and children from roughly 56 families began on a war footing. The settlements were essentially evacuated within a few hours. A few Thangkul Naga families remained in their settlements in the downstream area as they weren't a party to either side in this battle.

Chapter 2 (Page 13)

Separate reports of these gruesome killings from that fateful night were made to the Ministries of Home Affairs and Defence. Delhi gave the directive to keep silent about the situation. The Chief Minister of Manipur had received stern warnings in this regard from Delhi. No major bloodshed have been recorded in Manipur since that fateful night. However, sporadic incidents of violence have been reported and are still being reported across the state.

Chapter 3 (Page 18 last para)

On the night of July 3, as the entire family went to bed, Gunleiba informed his wife that he would fight for the country. He'll fight in the front lines to keep the Kukis from encroaching on their area. It is his responsibility to safeguard his motherland and community. Gunleiba's wife tried to persuade him until midnight. But he refused to accept. "I'm not going to kill anyone," he said." I'm only going to defend my country and village. I'll return once the war is over." The following morning, Gunleiba left his home at around 7 a.m. after breakfast. His wife couldn't even imagine Gunleiba was going to actual war. Otherwise, she would have tried to stop him anyway or inform the in-laws otherwise,

Chapter 4 (Page 22 last para to page 23)

Nancy Chinthianniang, aged 29, got married to a businessman Goulalsang Gangte in March of this year. Nancy's father-in-law Lienbau Gangte is a senior officer in the Manipur Police while her mother-in-law Gojabhung is an Under Secretary in the Manipur Government's Animal Husbandry department. The ancestral home of Gangte family is in Lamka, a town in Churachandpur. Nancy's father-in-law travelled to Lamka from Imphal on May 3 after hearing about the unrest in Churachandpur. Meanwhile, the situation in Imphal escalated in the afternoon of May 3 after the violence in Churachandpur broke out. In Imphal valley, Kuki settlements were targeted. Sensing danger, Nancy sought refuge in a relative's house in the Langol neighbourhood in Imphal for the night. She was assured that nothing would happen in that neighbourhood as it was home to most of the Ministers.

Chapter 4 (Page 26 1st para)

Jamgaikhim, along with two other relatives, were put on the street and tortured. A relative tried to protect the infant kid in her arms. But, to understand how cruelty, hatred and malice can be, the women in that crowd slapped even the infant kid. Nancy, who was being pummelled among the mob, was observing these awful images from a distance.

Chapter 4 (Page 26 last para)

Meanwhile, a rioting mob was on the loose. The mob quickly arrived onto the scene and threatened the policemen that if the woman is helped, they will all be killed. The policemen fled in terror. The thrashing-punching-kicking began again after that. Nancy received a powerful hit to her head, collapsed and lost consciousness.

Chapter 4 (Page 28 1st para)

Meanwhile, Jamgaikhim felt unsafe in the camp. Somehow, she managed to book a flight to Delhi for May 10. However, the army brought them to Imphal airport four days before the scheduled departure. The CISF didn't let anyone enter the airport before the day of the departure. Sensing the danger of remaining outside the airport, Jamgaikhim edited the journey date in her ticket in her mobile. That's how she made her family enter the airport before the actual journey date. Jamgaikhim and two other relatives spent three nights at the airport with the infant on their lap before flying to Delhi on May 10.

Chapter 5 (Page 32 last para to page 33)

In these past three months, Nohouchong and Jeetin only had a few conversations over the phone. It was enough for them that their family was still alive after all of this brutality. Jeetin and Nohouchong's plight is a household reality in conflict torn Manipur. Many such families have lost their loved ones and many more are displaced just because they were from different ethnicities.

Chapter 10 (Page 77 1st para)

The Ministry of Home Affairs arranged a special helicopter for taking the delegates to Imphal. However, a problem surfaced when they were about to board the chopper. A Meitei pilot was in charge of the cockpit. The Kuki leaders quickly got off the chopper and they were not ready to fly in that under any circumstances. Home Ministry officials made every effort to convey that it was a BSF helicopter. There is no such thing as Meitei or Kuki in the army. The Kuki leaders were in no mood to listen. Even, a Kuki leader said, "The pilot can crash the chopper on the hills with us. I don't trust any Meitei. We are not at al! willing to commit suicide" he said. With no other way out, an army helicopter was flown in from Aizawl, the capital city of Mizoram. After nearly three hours, the ITLF delegation took off in that chopper for Imphal."

- That, the true facts of the present crisis is that the current crisis in the State of Manipur was started on 3rd of May, 2023 at Churachandpur District whereby the major tribal community of Churachandpour District along with their Militant groups started to burn down houses of the minority Community and their lives living at Churachandpur District, Manipur and consequently, it has provoked the sentiments of the people of Manipur of different communities at large and is speedily gathering its momentum in the form of General Public agitation and anger. However, I am mainly targeting at present to bring the peace and harmony amongst the community of Manipur.
- That, in the said book the accused has portrayed the Meeteis community as demons in various parts of the book as the accused has written many words which could provoke hatred, feeling of enmity, ill will against the Meeteis community not only amongst kuki tribe but also amongst other communities of people residing with the country including Barak Valley and the Silchar Town. The accused has projected the Meeteis are racist and the Meeteis CSOs namely Arambai Tengol, Meetei Leepun and Meirapaibis have been termed as terrorist and extremist. The accused has done so at the instants of missionary trying to disintegrate India in the name of religion and language. The accused has used imputations against the Meeteis community at the instants of forces against India and such imputations, assertion in the book "Manipur Files" is prejudicial to the National Interest of India. In the book, the accused has used insulting and derogatory words for Meeteis women in general.

That, the said Book "Manipur Files" is completely based on false story mentioning about events leading up to the dehumanizing ethnic cleansing pogrom which is never been the ground reality of the present crisis.

The said Book i.e. "Manipur Files" itself clearly reveals his ill-intention which is fueling the ongoing crisis and it has interrupt to the process for restoration of peace and harmony amongst the communities of Manipur. The said documentary book has been fueling the crisis by spreading wrong information amongst the different communities of the State of Manipur and if the said book still continues to circulate amongst the people, then the present crisis will also continue resultantly losing the lives of many innocent people.

- That, it is further submitted that by this criminal acts, the accused person has caused hatred feeling of ill will against the Meeteis' community and also acts against National Integration. Hence, the accused is liable to be punished and the book is required to be confiscated and prevented from being soul.
- 7. That, I being a peace loving and responsible citizen of India, am compelled to file the present complaint against the said accused after having perused above false, fabricated and motivated Book.

In the light of the above mentioned facts and circumstances it is therefore prayed that an appropriate action for registration of FIR for the cognizable offences under for investigation and necessary action for punishing them in accordance with law in the larger interest of the society and also for maintaining law and order in the State of Manipur.
