

Today i.e. 26th November 2023 at 9.30pm received an information that on the same day at @ 9.20pm one organisation named as Manipur People's Assembly led by Ningthouja Lancha, arrange to organize a gathering programme for "**MANIPUR MIYAM GI KHAI CHENG (MANIPUR PEOPLE'S ASSEMBLY)** Opening Session 27 Nov. 2023 Commemorating the first Historic Session of Manipur State Assembly 1948 "**WAREP-THA**" November 27, 2023 to January 3, 2024 without any permission from concerned authority. The said Ningthouja Lancha has in-fact propagate his own secessionist agenda through the observance of gathering programme, thereby challenging the dissolution of Manipur's Constitution framed in the year 1947 and Assembly on September 21st, 1949. His said activities amount to challenging of the law and order of the Government of Manipur, with clear intention to overthrow the law duly established by the Government. As such prevention of him from continuing such activities are of great public importance in view of the various hardships faced by the innocent people of Manipur.
