That, The Kuki-Zo community have left behind all our properties due to the Law and Order situation which erupted on 3<sup>rd</sup> of May 2023 whilst leaving for a safe place i.e. IGAR(SOUTH), Mantripukhri, Imphal.

That, as suggested by the office authority, Shri RK Amarjit Singh, PEX (Staff's quarter in-charge) was given the responsibility to look after and ensure safety and protection of the quarters left by allottees from any miscreants. As such, all the allotees surrendered their quarter keys to him. All properties we left in our quarters remained untouched and safe till the 15<sup>th</sup> of October 2023.
