

Today ie 27/11/2023 at 6.35 pm received an information that on the same day at about 6 pm one Honda Activa grey color bearing Regd. No. MN06SE-1700 and TVS Ntroq bearing Regd. No. MN06SG-7490 which were coming from South to North along Imphal Ukhrul Road was knocked down by a four wheeler Chevrolet Uva grey color bearing Regd. No MN04A-6182 which was also coming from opposite direction at near Khurai Chairenthong due to rash or negligent driving on the part of the car driver. As a result of which both the riders and pillion rider of TVS Ntroq were received injury on their persons and they were evacuated to Raj Medicity Hospital for medical treatment. And both the vehicle Honda Activa and TVS Ntroq were also badly damaged.
