

Porompat on 6th may 2023 due to the ethnic violence that erupted in the state to save our lives. It has come to my knowledge that on 21th November 2023 some miscreants have entered my house and looted my property worth Rs:25 Lakh including Beds, Almerah, Arm Benches, Chair, Gas Cylinders, Refrigerator, Washing Machine, Television, TV stand, Dining Table, Blankets, Gold Ornaments, Kitchen Items, Electronic Gadgets and Clothing etc.

I there, request you to registered on FIR against the Culprits and take up necessary legal action regarding the incident
