

Sir,

With due respect, I have the honour to state that
On 3rd May, 2023 at around 6:00 PM, some miscreants
belonging to Meitei/Metei youths of Meitei World Council,
Kangpokpi Kanba dup (KKL) and Asambai Penggol
along with local Meitei populace carrying sticks, iron rods,
etc in large number entered my house which is situated
at 3rd street, New Lomabane, Imphal, without any reason
and started beating my husband, Thangalam Thuthong,
until he is in an unconscious state. Some photos taken
are attached to this FIR application copy. This type of
murder attempt on an innocent civilian is totally
unacceptable. I therefore pray that the culprits may
be apprehended and suitable punishment may be awarded
under the law of the land at the earliest. I request you
to kindly register FIR in this subject matter.

I would also like to state that the victim had
undergo medical treatment in Imphal which is why
I cannot file FIR in appropriate time.
