

Subject:- Zero FIR on my looted belongings from my DDK Staff Quarter No.C/27,
Porompat, Imphal East, Manipur on the 16th Oct.,2023.

Sir,

With due respect, I would like to lodge an FIR regarding looting of my Household items and properties kept in DDK Staff Quarter No.C/27, Porompat, Imphal East on the 16th October, 2023 at around 9.30 AM.

That Sir, consequent to the communal conflicted that suddenly erupted on May the 3rd of this year. I along with my family had to flee from our officially allotted quarter at DDK Staff Quarter No.C/27, Porompat, Imphal East, Manipur where I along with my family members have been living there for the past 25 years. We were rescued by Assam Rifles and kept at Assam Rifles Transit Camp, Minuthong, Imphal on the 7th May, 2023 leaving behind all our household items and properties in our Quarter by locking with a key and the same keys were handed over to our Office Staff Quarter Care-taker Shri R.K. Amarjeet Singh, Pex. Under the instruction of the Head of Office to Safeguard and protect our belongings from unwarranted activities till the time normalcy restored in the state. It was also reported through our colleagues that no untoward had happened in the colony till 15th of Oct. 2023.

On 14th Oct. 2023, I received a call from Shri Amarjeet Singh, Pex. (Staff Quarter In-charge) to make possible option to remove our valuable belongings. I along with other colleagues were discussing how to take out our belongings to a safer place. However I was shocked to learn that on 16th Oct. 2023, my Quarter No.C/27 was opened and allowed outside miscreants to loot all my belongings and properties. The loot appears to be in the knowledge of the staff who is responsible for caretaking the quarters.

In view of the above, I request you to kindly lodge an FIR on the reported loot and loss of my properties (belongings). I also request your good office to
