



I have the honour to report that today i.e. 6/12/2023 at @ 1.00pm my cousin brother namely Moirangthem Achoubi (62)yrs S/o Moirangthem Tombi of Kongba Nongthombam Leikai, Gangapat was knocked down by one Bullet bearing regd. No. MN01AH9989 while he walking at the roadside of Kongba Nongthombam Leikai in front of KYO Club due to rash or negligent driving on the part of Bullet rider. As a result of which my cousin brother received injury on his head, hand and some part of his body and evacuated to Advance Hospital for medical treatment.

It is therefore requested to kindly take up necessary legal action against the bullet rider according to law.
