

With reference to the above cited Subject, I have the honor to report to you as below:

1. That, I **Lalremthang Gangte**, Aged 35 S/o **Manga Gangte** belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act, 1989. Whereby, I had stayed as **Rent at New Checkon, P.S Porompat, Imphal East District.**

2. That, on 3<sup>rd</sup> May 2023, at 6:30pm, huge contingent of **Armed Radical Meitei/Meiteis, Arambai Tenggol and Meitei Leepun** attack our **Rent house** and in the process looted/vandalized our house and properties.

3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.71.80 lakhs only.

4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at **HQ Belam Veng, Churachandpur District.**

So, I could not make the said report on time due to present situation which unable me to do the report.

I, therefore, request you to register on FIR and bring justice.
