



Subject:- Report on vandalism and burning down of all properties from rented resident at Maring Lane, Checkon Road P.O & P.S- Porompat & District- Imphal East on 10-05-2023 at around 7pm.

Madam,

With due respect, I the undersigned would like to make a report to your good office about vandalism and burning down of all properties and house at Chinglangmei (Langza) P.O- CCpur Via Moirang & P.S- Kumbi & District- Churachandpur by a group of Meeitei/Meitei's suspected to be members of the Arambai Tengol and Meeitei Leepun along with Meitei Goon on dated 10-05-2023 at around 7:00 pm.

At the very outset, I would like to draw fewline for your information that due to the present situation of ethnic class between Tribal and Valley base Meitei/Meeitei from 3rd May, 2023. That due to the ethnic class suspected members of the Arambai Tengol and Meeitei Leepun never stop vandalism, looting of properties and killing of tribal people who are in the valley areas and hill areas till today. On 10-05-2023 at around 7:00 pm, a group of Meitei/Meeitei suspected to be members of the Arambai Tengol and Meeitei Leepun along with Meitei Goon and were looking for any person who is a Tribal (Hmar) for killing us. But, as we are already out from our resident and reach safer place my properties from my rented resident was burnt down by the so call Arambai Tengol and Meeitei Leepun Leepun. My properties inside my rented house were vandalized and burned down by them which worth Rs. 4,85,500/- (Rupees Four Lakh, Eighty Five Thousand and Five Hundred) only and presently I am taking shelter at relative residnet because I along with my family have no place to reside due to the said action in burning down of our property by the so call members.

It is requested to your good office to make entry of my report a Zero F.I.R and take action against all the above mention members, along with Meitei Goond who are the perpetrator for vandalism and burning down of all my properties as be are Tribal (Hmar) as per Law and also Issue me the copy of the said report for my reference in future. I could not make the said report on time due to avoidable circumstance of mine in looking after my family before staying at relief Camp.
