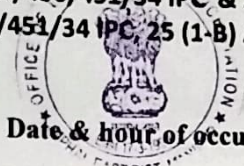





Subject: - Report on unlawful looting, vandalism, arson-attack and Discrimination of
Schedule Tribe.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. I am a schedule Tribe belonging to the any Kuki Tribe, which is a recognised tribe under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989, and I am a permanent resident of New Checkon, P.O. & P.S.- Porompat, district- Imphal East, Manipur.
2. That, on the 4th May 2023 at around 9:30 PM, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun, so in order to save our lives we left behind our belongings, and in the process they have looted then burnt down my rented house owned by (Retd. IAS Thangzasiang) including all our household items and documents, that includes;

Ex-Indian Army Documents:

- a) Pension Payment Order No.- D/2344/84
- b) Discharged Book
- c) Ex-Serviceman Identity Card

3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.50,00,000/- (Rupees Fifty Lakhs) only.
4. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
