

**Subject :- Report on Looting household items/assets, and discrimination of Schedule Tribes.**

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Hevei Haokip** aged about 31 years D/o (L) **Ngamlun Haokip** Belonging to the **Any-Kuki Tribe / Community**, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am staying in a rented house owned by **L Ibeton Devi** at **New Checkon Opposite Youth Club office Imphal-East, P.O & P.S., Porompat.**
2. That at about 8 pm on the **3<sup>rd</sup> May 2023**, due to the ethnic violence in the state I have to run for our lives leaving, behind our rented house along with all our belongings. and in the process some **unknown miscreants** have looted our rented house, including all our belongings and some Jewelleries (Gold) which is located in the above mentioned address.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.700000 ( Rupees Five Lakhs Fifty One Thousand) only**
4. Fortunately, I managed to escaped from the Violence, and now currently taking refuge at **B Aizalon ECA Church Relief Camp Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned relief Centre. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
